

The Bills will be in amounts of £5,000, £10,000, £25,000, £50,000, £100,000, £250,000 or £1,000,000. They will be dated at the option of the Tenderer on any business day from Monday, 29th June 1987 to Friday, 3rd July 1987, inclusive, and will be due 91 days after date.

The Bills will be issued and paid at the Bank of England.
