ST. EDMUNDSBURY BOROUGH COUNCIL

The Borough of St. Edmundsbury ("Pay and Display" Parking Places) Order, 1986 (Variation) Order No. 2, 1987

Notice is hereby given that on 27th August 1987, the St. Edmundsbury Borough Council made an Order under section 35 of the Road Traffic Regulation Act 1984, the effect of which will be to introduce disc season tickets as follows:

Car park	Season ticket charges
Parkway, Bury St. Edmunds	£3.75 monthly; £11.25 3 monthly
Prospect Row, Bury St. Edmunds	£7.50 monthly; £22.50 3 monthly
Ram Meadow, Bury St. Edmunds	£8.50 for 6 months
Ehringshausen Way, Haverhill	£5.50 monthly; £16.50 3 monthly
Helions Walk, Haverhill (rear of Town Hall)	£3.75 monthly; £11.25 3 monthly

The former season ticket scheme will be abandoned. There is no change in the rates of charge per occasion; in the time limits for which each parking place is available; in the days and hours of charge; nor in the classes of vehicles permitted at each car park.

The Order will come into operation on 7th September 1987.

Notice of the proposed Order was previously published pursuant to Regulation 5(1)(b) of the Local Authorities' Traffic orders (Procedure) (England and Wales) Regulations 1986 in the issue No. 51015 of the *London Gazette* dated 31st July 1987 under ref. No. 786. The effect of the Order is as described in that notice.

SALFORD CITY COUNCIL

The City of Salford (Clippers Quay, Salford 5) (Prohibition of Waiting) Order 1987
