ARCHITECTS (REGISTRATION) ACT 1931

The following amending Regulation made by the Architects Registration Council of the United Kingdom under section 13 of the above-mentioned Act has been submitted for the approval of the Privy Council.

REGULATION

Amend Regulation 38(a) to read as follows:

"38(a) The retention fee mentioned in section 13 of the principal Act shall be £19.00, but may be increased by resolution of the Council once only without further approval of the Privy Council by not more than 50%."
