BIRMINGHAM CITY COUNCIL

Birmingham City Council (Bordesley Green etc. Bordesley) (General Traffic Control) (Variation) and (Humpage Road etc. Bordesley) (Prohibition of Waiting) Orders 1987

Notice is hereby given that on 2nd December 1987, the abovenamed Council made the above-named Orders under sections 1(1) and (2), 2(1) to (3), 4(2) and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act the effect of which, is as follows:

To vary existing Traffic Regulation Orders following improvements to the Bordesley Green/Victoria Street/Bordesley Green Road road junction to take into account the new road layout and kerb realignment.

To introduce prohibition of waiting on certain lengths of Bordesley Green, Bordesley Green Road, Humpage Road, Norwood Road and Victoria Street, to ensure that parked vehicles do not obstruct bus stop positions, deceleration lanes or cause delays and obstructions to vehicular traffic flows.

To remove the loading ban between the hours of 12 noon and 2 p.m. on Saturday in certain lengths of Bordesley Green, Bordesley Green Road and Victoria Street.

To reduce the area over which driving is prohibited in Cherrywood Road at its junction with Bordesley Green Road.

To vary the West Midlands County Council (Cherrywood Road, Link, Birmingham) to include the Schedule of roads affected which was inadvertently omitted when the Order was made.

To revoke The City of Birmingham (Traffic Regulation) (No. 1) Order 1963.

The Orders will come into operation on 7th December 1987. A copy of the Orders together with a map and a statement of the council's reasons, are available for inspection at the offices of the City Solicitor, Paradise Place, Birmingham B3 3EH, during normal working hours.

If any person wishes to question the validity of the Orders or of any provision contained in them on the grounds that they are not within the powers conferred by the Act or on the grounds that any requirements of the Act or any instrument made under it has not been complied with in relation to these Orders may, within 6 weeks from 2nd December 1987 apply to the High Court for this purpose.
