Notice is hereby given that Westminster City Council propose, subject to the consent of the Secretary of State for Transport, to make the above-mentioned Order under sections 6 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 as amended by the Local Government Act 1985.

The general effect of the Order would be to:

(a) revoke the existing prohibition on all vehicles exceeding 3

tons unladen weight proceeding in the slip road linking Westway to Westbourne Terrace (referred to as "the northern slip road") and the slip road linking Ranelagh Bridge to Westway (referred to as "the southern slip road") imposed by the City of Westminster (Weight Restriction) Traffic Order 1970;

(ii) in respect of anything done in accordance with any restriction or requirement indicated by traffic signs placed on the highway by or on behalf of the Metropolitan Police.

(b) in paragraph 2(b)(ii) above would not apply:

(i) in relation to any vehicle when used in the service of a local authority in pursuance of statutory powers or duties provided that in all the circumstances it is reasonably necessary in the exercise of such powers or in the performance of such duties for that vehicle to proceed in the northern slip road, Ranelagh Bridge or the southern ellip road. the southern slip road;

(ii) in relation to any vehicle being used in connection with the maintenance, improvement, reconstruction, with the maintenance, improvement, reconstruction, cleansing or lighting of the northern slip road, Ranelagh Bridge, the southern slip road or of any road accessible only thereform, or the laying, erection, alteration or repair of any sewer thereunder or of any main, pipe or apparatus for the supply of gas, water or electricity or of any telecommunication system thereunder or thereon, or the placing, maintenance or removal of any traffic sign thereon;
