*The Trunk Road (A40) (Dixton, Monmouth)  
(Prohibition of Right Hand Turns) Order 1987*

Notice is hereby given, that the Secretary of State for Wales proposes to make an Order under sections 1 and 2 of the Road Traffic Regulation Act 1984.

The effect of the proposed Order will be to prohibit any vehicle travelling in a south-westerly direction on the trunk road from making a right hand turn into:

- (a) Manson's Lane at a point 270 metres north-east of the centre point of Dixton Roundabout, Monmouth, in the county of Gwent.
- (b) The private access road to Inglewood Guest House/Hotel at a point 410 metres north-east of the centre point of Dixton Roundabout aforesaid.
- (c) Newton Court Lane at a point 650 metres north-east of the centre point of Dixton Roundabout aforesaid.

A draft Order, together with a plan and statement of reasons for making the Order, may be inspected during normal office hours at the Offices of Monmouth District Council, Mamhilad Park Estate, Pontypool, and District Offices, Monmouth.

Objections, specifying the grounds on which they are made, and quoting reference WR15/3/352 must be sent in writing to the Welsh Office, Highways Directorate, Roads Administration Division, Government Buildings, Ty Glas Road, Llanishen, Cardiff CF4 5PL, by 25th November 1987. In the preparation of an objection and the statement of grounds of objection, it should be borne in mind that the substance of any objection or representation may be communicated to other people who may be affected by it.

*The Trunk Road (A48) (Cross Hands-Llanddarog By-Pass,  
Dyfed) (De-Restriction) Order 1987*
