SALMON AND FRESHWATER FISHERIES ACT 1975 Fishery Byelaw

Notice is hereby given that Northumbrian Water Authority intends to apply to the Minister of Agriculture Fisheries and Food, not less than one month after the date of publication of this Notice, for confirmation of a Byelaw made by the Authority

under the provisions of section 28(6) and Part II of Schedule 3 of the Salmon and Freshwater Fisheries Act 1975 the effect of which is to create a Playground around the mouth of the River Tees is to create a Playground around the mouth of the River fees bounded on the north-east by a straight line drawn from the Cooling Tower at Longhill, Hartlepool to the Tees Fairway Buoy and on the south-east by a straight line drawn from a point 1350 metres in a straight line southwards from the landward end of South Gare Breakwater to the Tees Fairway Buoy. The use of nets other than T nets authorised by virtue of the Northumbrian Water Authority (T Nets) (Southern Area) Order 1987 is prohibited within this area up to the boundaries of an inner box within which all nets for fishing for or taking salmon, trout or prohibited within this area up to the boundaries of an inner box within which all nets for fishing for or taking salmon, trout or freshwater fish are prohibited. This inner box is bounded on the north-east by a straight line drawn from the Tees Fairway Buoy to a point on the coastline 500 metres in a straight line northwards from the landward end of the North Gare Breakwater and on the south-east by a straight line drawn from the Tees Fairway Buoy to a point on the coastline 500 metres in a straight line southwards from the landward end of the South Gare Breakwater.

During the period of one month from the date of publication of this Notice printed copies of the said Byelaw will be deposited at the offices of the Authority (Northumbria House, Regent Centre, Gosforth, Newcastle-upon-Tyne NE3 3PX) and will be open to public inspection without charges on any weekday other than Saturday during normal office hours.
