Notice is hereby given that the Oldham Borough Council in exercise of the powers conferred on them by section 11 of the Clean Air Act 1956 as amended, intend to make the above Orders, the effect of which will be to: amend the 1967 Order by making the following properties subject to the smoke control provisions:

Victoria Street No's. 9-17 (odd)
Radcliffe Street No. 61
Burnley Lane No's 39, 74 and 76

amend the 1977 Order by making the following properties subject to the smoke control provisions:

Thorpe Lane No's 39, 55 and 57
The Nook No. 1
Huddersfield Road No's 743-749, 769-785 (odd) 785B, 787-799,
805-807, 809-811 and 813-819 (odd)
Slack Hall No's 8-14 (even)

The smoke control provisions mean that (subject to any exemptions) smoke must not be emitted from any chimney of any of these properties.

These Variation Orders are now about to be submitted to the Secretary of State for the Environment for confirmation.

It is intended the Orders shall come into operation on 1st April 1989. A copy of the draft Orders and plans to which they relate may be inspected at the Civic Centre, Room 447 during all reasonable times until 4th January 1988.
