1. Brancaster Road

(a) the north side

(iii) between its junction with Stainforth Road and a point 20 metres east of that junction

(ii) between a point 33 metres east of the eastern kerb-line of Stainforth Road and a point 3 metres west of the common boundary of Nos. 3 and 5 Brancaster Road

(iii) between a point 2 metres west of the eastern boundary of No. 11 Brancaster Road and a point 6 metres east of its junction with the eastern kerb-line of Buxton Road

(iv) between a point 6 metres west of the common boundary of Nos. 33 and 35 Brancaster Road eastwards for a distance of 11 metres

(i) between its junction with Suffolk Road and a point 4 metres west of the common boundary of Nos. 3 and 5 Chepstow Crescent (ii) between a point 9 metres east of the common boundary of Nos. 3 and 5 Chepstow Crescent and a point 14 metres south-east of the common boundary of Nos. 25 and 27 Chepstow Crescent

(iii) between its junction with Aldborough Road South and a point 17 metres north-west of that junction.

(b) the south and south-west side

(i) between its junction with Suffolk Road and a point 4 metres south-west of the common boundary of Nos. 12 and 14 Chepstow Crescent

(ii) between a point 2 metres north-east of the common boundary of Nos. 12 and 14 Chepstow Crescent northeastwards for a distance of 12 metres

(iii) between a point 2 metres north-east of the common boundary of Nos. 16 and 18 Chepstow Crescent and its junction with Aldborough Road South.

5. Church Road

(i) between its junction with Stainforth Road and a pont 10 metres east of that junction

(iv) between a point 2 metres west of the common boundary of Nos. 31 and 33 Church Road and a point 1 metres east of the common boundary of Nos. 35 and 37 Church Road

(v) from the common boundary of Nos. 41 and 43 Church Road eastwards for a distance of 13 metres

(ii) between a point 1 metre east of the common boundary of Nos. 7 and 9 Clifton Road and a point 1 metre west of the common boundary of Nos. 15 and 17 Clifton Road

(iii) between a point 1 metre west of the common boundary of Nos. 19 and 21 Clifton Road and a point 1 metre west of the common boundary of Nos. 25 and 27 Clifton Road

(iv) between the common boundary of Nos. 29 and 31 Clifton Road and a point 13 metres east of the eastern kerbline of Lancing Road

(v) between a point 5 metres west of the western boundary of No. 37 Clifton Road and a point 30 metres west of its junction with Glebelands Avenue

(vi) between a point with Glebelands Avenue and a point 17 metres west of that junction

(b) the south side

(i) between its junction with Ley Street and a point 5 metres east of the eastern junction of No. 36 Clifton Road

(ii) between a point 17 metres west of the western kerbline of Lancing Road and the common boundary of Nos. 54 and 56 Clifton Road

(iii) between a point 1 metre east of the common boundary of Nos. 60 and 62 Clifton Road and its junction with Glebelands Avenue.
