- (ii) between a point 5 metres north-east of the common boundary of Nos. 13 and 15 Kelsie Way and a point 7 metres north-east of the common boundary of No. 27 Kelsie Way and No. 12 Inverness Drive.
- (iii) between the junction with Inverness Drive and a point 10 metres south-west of that junction.

- (i) between the junction with Lancelot Road and the common boundary of Nos. 2 and 4 Kelsie Way.
- (ii) between a point 1 metre north-east of the common boundary of Nos. 6 and 8 Kelsie Way and a point 3 metres north-east of the common boundary of Nos. 22 and 24 Kelsie Way.
- (iii) between a point 7 metres north-east of the common boundary of Nos. 24 and 26 Kelsie Way and the junction with Inverness Drive.

- Excluding that length of carriageway as extends from a point 12 metres north-west of the north-western kerb-line of New North Road, north-westwards for a distance of 18 metres.
14. *Lagonda Avenue*
- (a) the north-west side, excluding that length of carriageway as extends from a point 8 metres south-west of the south-western kerb-line of Penrith Road, south-westwards for a distance of 12 metres.
- (b) the south-east side, excluding that length of carriageway as extends from the common boundary of Nos. 1 and 3 Lagonda Avenue, south-westwards for a distance of 12 metres.

- (i) between the junction of New North Road and the common boundary of Nos. 2 and 4 Lancelot Road.
- (ii) between the common boundary of Nos. 14 and 16 Lancelot Road and the common boundary of Nos. 18 and 20 Lancelot Road.
- (iii) between the common boundary of Nos. 26 and 28 Lancelot Road and the junction with Walden Way.
- (b) the east side
- (i) between the junction of New North Road and a point 9 metres south of that junction.
- (ii) between a point 8 metres north of the northern boundary of No. 1 Lancelot Road and the common boundary of Nos. 17 and 19 Lancelot Road.
- (iii) between a point 13 metres south of the common boundary of Nos. 21 and 23 Lancelot Road and the junction with Walden Way.
17. *Lime Grove*
- (a) the south-west side
- (b) the north-east side
- (i) between the junction of New North Road and a point 12 metres north-west of that junction.
- (ii) between a point 8 metres south-east of the common boundary of No. 2 Lancelot Road and No. 319 New North Road and a point 1 metre north-west of the common boundary of Nos. 8 and 10 Lime Grove.
- (iii) between a point 4 metres south-east of the common boundary of Nos. 12 and 14 Lime Grove and a point 3 metres south-east of the common boundary of Nos. 26 and 28 Lime Grove.
- (iv) between a point 3 metres north-west of the common boundary of Nos. 26 and 28 Lime Grove and a point 3 metres north-west of the common boundary of Nos. 34 and 36 Lime Grove.

18. *Marian Close*
- (a) the north-east side
- (b) the south-west side
- (i) between the junction of New North Road and a point 7 metres north-west of that junction.
- (ii) between a point 19 metres north-west of the junction with New North Road and the south-eastern boundary of Nos. 1/2 Marian Close.
- (iii) between a point 3 metres north-west of the common boundary of Nos. 3/4 and 5/6 Marian Close and the north-western extremity.
- (c) the north-western extremity.
19. *Maypole Crescent*
- (a) the south-west arm
- (i) the south-west side between the junction with New North Road and a point 1 metre north-west of the south-eastern boundary of No. 1 Maypole Crescent.
- (ii) the south-west side between a point 2 metres south-east of the common boundary of Nos. 7 and 9 Maypole Crescent and the common boundary of Nos. 9 and 11 Maypole Crescent.
- (iii) the south-west side between the common boundary of Nos. 19 and 21 Maypole Crescent and the north-west extremity.
- (iv) the north-east side excluding that length of carriageway as extends from a point 7 metres north-west of the north-western kerb-line of New North Road, north-westwards for a distance of 16 metres.
- (b) the north-west arm
- (i) the north-west side, excluding that length of carriageway as extends from the common boundary of Nos. 31 and 33 Maypole Crescent and the common boundary of Nos. 49 and 51 Maypole Crescent.
- (ii) the south-east side.
- (c) the north-east arm
- (i) the south-west side, excluding that length of carriageway as extends from a point 11 metres north-west of the north-western kerb-line of New North Road, north-westwards for a distance of 12 metres.
- (ii) the north-east side, excluding that length of carriageway as extends from a point 3 metres north-west of the south-west boundary of No. 73 Maypole Crescent and the common boundary of Nos. 57 and 59 Maypole Crescent.
20. *New North Road*
- (a) the north-west side
- (i) between the north-east wall of No. 7 New North Road and the common boundary of Nos. 11 and 13 New North Road.
- (ii) between a point 1 metre north-east of the common boundary of Nos. 15 and 17 New North Road and a point 1 metre south-west of the common boundary of No. 43 and 45 New North Road.
- (iii) between the common boundary of Nos. 47 and 49 New North Road and the common boundary of Nos. 259 and 261 New North Road.
- (iv) between the common boundary of Nos. 261 and 263 New North Road and the north-east boundary of No. 325 New North Road.
- (b) the south-east side
- (i) between a point 15 metres south-west of the south-western boundary of No. 18 New North Road and the common boundary of Nos. 220 and 222 New North Road.
- (ii) between the common boundary of Nos. 222 and 224 New North Road and the common boundary of Nos. 226 and 228 New North Road.
