#### The East Sussex (C19, Bodiam and Ewhurst) (Prohibition of Waiting) Amendment No. 1 Order 1987

Notice is hereby given that East Sussex County Council proposes to make an Order under sections 1(1) and (2), 2(1) to (3) and 4(2) of, and Part IV of Schedule 9 to, the Road Traffic Regulation Act 1984 which will extend the seasonal waiting restriction along part of the C19 road at Bodiam by amending "The East Sussex (C19, Bodiam and Ewhurst) (Prohibition of Waiting) Order 1975". The effect of the Order will be to prohibit waiting along both sides of the C19 road, from the point where the present length of "No Waiting at any time" finishes near the Old Rectory, north-westwards on its south-west side for a distance of 555 metres and on its north-east side for a distance of 518 metres.

on its north-east side for a distance of 518 metres. It is intended that this measure will prevent drivers from causing dangerous

obstructions by parking on the hill and near bends in this area. The proposed Order will not affect the exceptions contained in the existing Order.

A copy of the draft Order containing full details of the proposal, together with a statement of the County Council's reasons for proposing to make the Order and a plan showing the lengths of road affected, may be examined at my office between the hours of 9 a.m. and 4 p.m., on Monday to Friday inclusive, and at Robertsbridge Post Office, 22 High Street, Robertsbridge, during normal opening hours until 12th December 1987.

## EALING LONDON BOROUGH COUNCIL

# The Ealing (Waiting and Loading Restriction) (Amendment No. 41) Order 1987

Notice is hereby given that the Council of the London Borough of Ealing made the above-named Order under section 6 and 124 of and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act"). The Order will come into operation on 18th November 1987.

The general effect of the Order will be to further amend the Ealing (Waiting and Loading Restriction) Order 1977, so that:

- (a) waiting by vehicles (otherwise than for the purpose of delivering or collecting goods or loading or unloading a vehicle) will be prohibited between 8 a.m. and 6.30 p.m. on Mondays to Saturdays inclusive in the lengths of streets specified in the Schedule to this notice.
- (b) waiting by vehicles for the purpose of delivering or collecting goods or loading or unloading a vehicle for a period of more than 20 minutes in the same place will be prohibited between 11 a.m. and 6.30 p.m. on Mondays to Saturdays inclusive in the lengths of streets referred to in paragraph (a) above.
- (c) the sale or offer for sale of goods from a vehicle, in the lengths of streets referred to in sub-paragraph (a) above, will be prohibited, except on a Sunday, unless there is in force a valid licence issued by the Ealing Borough Council or the goods are immediately taken into or delivered at the premises adjacent to the vehicle from which the sale is effected:
- (d) the use of any vehicle or of any animal or the wearing of fancy dress or other costume, wholly or mainly for the purpose of advertising, will be prohibited;

The prohibitions referred to in paragraph 2(a) will not apply in respect of anything done with the permission or at the direction of a police constable in uniform or in certain circumstances, e.g. the picking up or setting down of passengers; the carrying out of statutory powers or duties, the taking in of petrol, etc., from roadside petrol stations; trading by licensed street traders, etc. The usual exemption relating to vehicles displaying a disabled person's "Orange Badge" will apply. A copy of the Order may be inspected until 30th December 1987, between the hours of 8.30 a.m. to 4.30 p.m., Mondays to Thursdays inclusive, and between the hours of 8.30 a.m. and 4.15 p.m. on Fridays in Room U/361, 22-24 Uxbridge Road, Ealing W5 2BP. Copies of the Order may be bought there. Any person desiring to question the validity of the Order or any provision contained therein on the grounds that it is not within the powers of the Act or that any of the requirements

within the powers of the Act or that any of the requirements thereof or of any relevant regulations made thereunder has not been complied with may within 6 weeks from the date on which the Order was made, make application for the purpose to the High Court.
