SOUTH WEST WATER AUTHORITY

CLEVELAND COUNTY COUNCIL

The County Council of Cleveland (Former A171 Slapewath) (Prohibition of Driving) Order 1987

LAMBETH BOROUGH COUNCIL

The Lambeth (Bus Lane) (No. 1) Traffic Order 1987 The Lambeth (Waiting and Loading Restriction) (Amendment No. 39) Order 1987.
