*The District of Huntingdonshire  
(Off-Street Parking Places) Order 1988*

Notice is hereby given that the Huntingdonshire District Council propose to make an Order under Section 35(1) and (3) of the Road Traffic Regulation Act 1984 and of Part IV of Schedule 9 to the Act and of all other existing legislation, to control the use of the parking places named in Schedule 1 to this notice, which shows the classes of vehicles, the days and times of operation, the maximum period of waiting and the scale of charges proposed for each parking place.

The Order will specify the conditions under which the parking places may be used. Full details are contained in the draft Order which, together with the maps showing the location of the parking places and a statement of reasons for making the Order, may be seen at:—

- (a) Pathfinder House, St. Mary's Street, Huntingdon—During normal office hours.
- (b) The Town Hall, St. Ives—During the Town Clerk's normal office hours.
- (c) St. Neots Town Council Offices, 32a New Street, St. Neots—During the Town Clerk's normal office hours.

In the case of the parking places described:—

- (a) In column (1) of Schedule 2 to this Notice the Order will provide for the issue of tickets to the residents of premises in the street referred to in column (2) of the Schedule exempting them from limitations of time imposed under Schedule 1 of the Order.
- (b) In column (1) of Schedule 3 to this Notice the Order will provide for the issue of season tickets at the scale of charges set out in column (2) of the Schedule exempting holders from the limitations of time imposed under Schedule 1 of the Order.

In the event of anyone wishing to object to this Order, their objection, with the grounds for making it, should be made in writing to the undersigned not later than Wednesday, 16th December 1987.
