

The (A6) London-Carlisle Trunk Road (Chapel-en-le-Frith and Whaley Bridge Bypass) (Prohibition of Right Turns) Order 1987.

The Secretary of State for Transport hereby gives notice that he has made an Order under sections 1(1) and (2) and 2(1) and (2) of the Road Traffic Regulation Act 1984 on the (A6) London-Carlisle Trunk Road.

The effect of the Order, which comes into force on 23rd November 1987, is to prohibit vehicles making a right turn—

- (a) into the northbound carriageway of (6) Chapel-en-le-Frith and Whaley Bridge Bypass from the southbound access slip road which leads from Sheffield Road (A625); or
- (b) into Buxton Road from the southbound carriageway of that bypass, at Chapel-en-le-Frith.

all in the Borough of High Peak in the County of Derbyshire.

Notice of the Secretary of State's intention to make this Order was published under the reference number T8396/28/0680 on 12th August 1987 in the *London Gazette*. The effect of this Order is the same as described in that Notice.

THE ROAD TRAFFIC REGULATION ACT 1984

The (A6) London-Carlisle Trunk Road (Chapel-en-le-Frith and Whaley Bridge Bypass) (One-Way Traffic) Order 1987.

The Secretary of State for Transport hereby gives notice that he has made an Order under sections 1(1) and (2) and 2(1) and (2) of the Road Traffic Regulation Act 1984 on the (A6) London-Carlisle Trunk Road.

The effect of the Order, which comes into force on 23rd November 1987, is to impose one-way traffic regulations on the southbound access slip road leading into (A6) Chapel-en-le-Frith and Whaley Bridge Bypass from (A625) Sheffield Road between a point 22 metres south of its junction with Blackbrook Lane and a point 82 metres south of that junction, allowing traffic to proceed in a southwards direction only.

TOWN AND COUNTRY PLANNING ACT 1971

Proposed Stopping Up of a Length of Oakdale Road, Seacombe, Wirral.

Notice of Application for a Licence to obstruct or impede the flow of an inland water by means of impounding works

Notice is hereby given that an application is being made to the Anglian Water Authority by Melvyn George Evans for a licence to obstruct or impede the flow of Lyddington Brook, by means of a clay dam, at National Grid Reference 8750/9750 in the Parish of Lyddington in the District of Uppingham in the County of Leicestershire.

The object of impounding water by means of the works is fish lakes and conservation area.

The capacity of the reservoir at overflow level will be 4046.86 cubic metres.
