PRIVY COUNCIL OFFICE

ARCHITECTS (REGISTRATION) ACT 1931

The following amending Regulation made by the Architects Registration Council of the United Kingdom under section 13 of the above-mentioned Act has been submitted for the approval of the Privy Council.

Regulation 37 (1)

Delete existing Regulation 37 (1) and substitute

"(1) On applications for registration under section 6 of the principal Act the fees shall be as follows:

- (a) £3.00 on an application made pursuant to section 6 (1) (c) of the principal Act or to Regulation 26 (i), (ii), (iv) or (v) or section 6A;
- (b) £50 on any other application;
- (c) £20 in addition to the sums named in sub-paragraphs (1) (a), (b), payable in advance, by an applicant who sits an examination in Professional Practice and Practical Experience as may from time to time be held by the Board by virtue of section 6 (4) of the principal Act.

The purpose of this Regulation is to amend the amount of admission fees.".

Representations by persons to whom the Regulation is applicable may be made in writing to the Privy Council on or before 1st December 1987.

UNIVERSITIES OF OXFORD AND CAMBRIDGE ACT 1923

A Statute made by the Governing Body of All Souls College, in the University of Oxford on 3rd November 1987, amending Statute IX has been submitted for the approval of Her Majesty in Council, and notice of its having been so submitted is published in accordance with the provisions of the Universities of Oxford and Cambridge Act 1923.

This amendment will enable the College to employ Chartered Accountants not restricted to those carrying on business in London or Westminster.

The purpose of the amendment is to fail to comply with the University's Code of Practice on Freedom of Speech.

TOWN AND COUNTRY PLANNING ACT 1971

The Secretary of State for Transport hereby gives notice that he has made an Order under section 209 of the above Act entitled "The Stopping Up of Highways (County of Devon) (No. SW6) Order 1987" authorising the stopping up of part of Swedwell Road, Torquay.

Any person aggrieved by the Order and desiring to question the vailidity thereof, or of any provision contained therein, on the ground that it is not within the powers of the above Act or that any requirement of that Act of or any regulation made thereunder has not been complied with in relation to the Order, may within 6 weeks of 18th November 1987, apply to the High Court for the suspension or quashing of the Order or of any provision contained therein.
