The Secretary of State for Transport hereby gives notice that he proposes to make the following Orders:

- 1. The London-Portsmouth Trunk Road (A3 Milford By-pass and Slip roads) Order 198, under sections 10 and 41 of the Highways Act 1980, which will provide that roads which he proposes to construct along the following routes shall become trunk roads as from the date when the Order comes into force:
 - (i) a route (the main route) about 1.96 kilometres in length at Milford in the County of Surrey between Lower Eashing and Rodborough Hill, and
 - (ii) routes for slip roads to connect the main route with existing routes at Elstead Road (B3001).
- 2. The London-Portsmouth Trunk Road (A3 Milford Detrunking) Order 198, under sections 10 and 12 of the Highways Act 1980, which will provide that a length of the London-Portsmouth Trunk Road (A3) to be superseded by the new trunk road on the main route mentioned above shall cease to be a trunk road, and shall be classified as a principal road, as from the date on which the Secretary of State notifies the County Council of Surrey (who will become the highway authority responsible for that length) that the said new trunk road is open for through traffic.
- 3. The London-Portsmouth Trunk Road (A3 Milford By-pass Side Roads) Order 198, under sections 12, 14 and 125 of the Highways Act 1980, authorising him:
 - (a) to improve, raise, lower or otherwise alter highways,
 - (b) to stop up highways,
 - (c) to construct new highways, and
 - (d) to stop up private means of access to premises,

all at Milford and Lower Eashing aforesaid, and providing for the transfer of each of the said new highways to the County Council of Surrey as from the date on which he notifies that Council that the new highways have been completed and are open for through traffic.

Any person may not later than 29th February 1988 or within 13 weeks from the date of publication of this notice, if such period shall expire later, object to the making of the Orders, by notice to the Secretary of State, at his South East Regional Office, quoting ref. RSE A3/6A/65/2/1 and stating the grounds of objection. In the preparation of an objection and the statement of grounds of objection it should be borne in mind that the substance of any objection or representation may be communicated to other people who may be affected by it.
