### PARLIAMENTARY NOTICES

#### PRIVATE LEGISLATION PROCEDURE (SCOTLAND) ACT 1936

Notice is hereby given in terms of section 1(4) of the Private Legislation Procedure (Scotland) Act 1936 that the Secretary of State for Scotland, the Chairman of Committees of the House of Lords and the Chairman of Ways and Means in the House of Commons having considered the representation by the International Management Centre from Buckingham Ltd. that it is expedient that the under-mentioned Parliamentary powers, to be operative in Scotland and England, which the Centre desires to obtain should be conferred by one enactment, have decided that the said powers would more properly be obtained by the promotion of a Private Bill than by the promotion of a Private Bill and of a Provisional Order under the said Act.

1. To incorporate by Statute the International Management Centre from Buckingham Limited ("the Centre"), providing a constitution for it and stipulating what its objects shall be.
2. To confer miscellaneous powers on the Centre and to authorise the Centre to charge fees.
3. To authorise the Centre to award degrees of membership.
4. To authorise the making of bye-laws, regulations and ordinances for the administration and conduct of the Centre.
5. To provide for the keeping and auditing of accounts for the Centre and for the investment of monies.
6. To provide for the transfer of property from the International Management Centre from Buckingham Limited to the newly incorporated body.
7. To provide for the transfer of liabilities, saving of agreements etc., the construction of bequests in favour of the existing Company and for the continuation of the terms and conditions of those employed by the existing Company and the degrees of membership held at the time of transfer.
8. To provide for the dissolution of the existing Company.
9. Other incidental and miscellaneous purposes.
