NOTICE OF PROPOSALS OF THE THAMES WATER AUTHORITY TO ABSTRACT WATER

Notice is hereby given that the Thames Water Authority have made proposals for the variation of licence to abstract water No. 28/39/23/8 which authorises abstraction from Greys Road Pumping Station, Henley.

The Authority proposes to increase hourly and daily abstraction from 40,000 gallons and 850,000 to 42,000 gallons and 1,000,000 gallons respectively. However, the present annual quantity authorised to be abstracted, 310 million gallons, will remain unchanged. The Authority also propose to make minor amendments to the licence with regard to metrication and dates.

The Authority's proposals set out in the form of a draft variation together with the map deposited therewith, may be inspected free of charge at all reasonable hours during the period beginning on 27th November 1987 and ending on 28th December 1987 at the following offices of the Authority:
