

- (1) Vehicles will be prohibited from waiting at any time in certain parts of the following roads: Westgate, Ryton Street, Queen Street, Watson Road, Potter Street and Newcastle Street.
- (2) There will be a peak period loading/unloading prohibition between 8.15 a.m. and 9.30 a.m. and between 4 p.m. and 6 p.m. on certain parts of the following roads: Ryton Street, Watson Road, Potter Street and Newcastle Street.
- (3) One-way traffic operation will affect the following roads as indicated: (a) Bridge Place (from Netherholme Car Park access to Bridge Street) from north to south; (b) Bridge Street (from Bridge Place to Ryton Street) from north to south; (c) Queen Street (east) from east to west; (d) Queen Street (north) from south to north.
- (4) Vehicles will be prohibited from proceeding in certain parts of the following roads (there will be specified exemptions, some of which will not be effective between 10 a.m. and 3.30 p.m. on Mondays to Saturdays inclusive): Bridge Street, Bridge Place and Castle Street.
- (5) Certain vehicle turning movements will be prohibited as indicated: (a) Memorial Avenue (westbound) no right turn into Watson Road; (b) Newcastle Street (eastbound) no right turn into Watson Road; (c) Watson Road (northbound) no right turn into Memorial Avenue; (d) Watson Road (northbound) no left turn into Newcastle Street.
- (6) Certain existing one-way traffic restrictions will consequently be revoked in respect of parts of the following roads: Bridge Place, Bridge Street, Potter Street, Watson Road, Newcastle Street and Queen Street.
- (7) There will be consequential revocations of existing prohibitions which will be deleted or superseded. The usual exemptions will be provided.
