The City of Southampton (Freemantle Area) (Prohibition and Restriction of Waiting) (Amendment) Order 1987 The City of Southampton (First Controlled Zone) (Amendment No. 11) Traffic Regulation Order 1987

- (b) on the south side from the west side of the railway crossing eastwards to a point just east of the extended boundary of No. 24 Chapel Road.
- (c) on the south side of Chapel Road for 15 metres either side of the junction with Paget Street.

Paget Street

- (a) on the east side of Paget Street for 25 metres from the junction with Chapel Road.
- (b) on the west side of Paget Street for 15 metres from the junction with Chapel Road.

Hartley Avenue

On the south-east side of Hartley Avenue for a distance of 10 metres either side of its junction with Ripstone Gardens and Blenheim Gardens, on both sides for a distance of 10 metres north-eastwards from its junction with Welbeck Avenue and on both sides for a distance of 20 metres south-westwards from its junction with Granby Grove.

Granby Grove

On both sides for a distance of 20 metres south-eastwards from its junction with Hartley Avenue.

Ripstone Gardens

On both sides for a distance of 10 metres south-eastwards from its junction with Hartley Avenue.

Blenheim Gardens

On both sides for a distance of 16 metres south-eastwards from its junction with Hartley Avenue.
