The Secretary of State for Wales hereby gives notice that he proposes to make an Order under section 209 of the Town and Country Planning Act 1971 to authorise the stopping up of the highway described in the Schedule to this notice to enable development for which planning permission has been granted, to be carried out.

During the 28 days from 14th January 1988 copies of the draft Order and the relevant plan may be inspected free of charge at all reasonable hours at the Offices of Merthyr Tydfil Borough Council, Town Hall, Merthyr Tydfil.

Within the above mentioned period of 28 days any person may by written notice to the Welsh Office, Highways Directorate, Roads Administration Division, Government Buildings, Ty Glas Road, Llanishen, Cardiff, CF4 5PL (quoting ref. WR15/5/251), object to

the making of the Order, stating the grounds for objection. In the preparation of an objection, it should be borne in mind that the substance of any objection or representation may be communicated to other people who may be affected by it.

SCHEDULE

(all distances are approximate)

The highway to be stopped up is at Dowlais, Merthyr Tydfil in the County of Mid Glamorgan and is that length of the highway known as Mary Ann Street which extends from its junction with Mount Pleasant Street in a general south-easterly direction to its junction with Upper Elizabeth Street, a distance of 132 yards. (6 SI)

The Secretary of State for Wales hereby gives notice that he proposes, subject to the granting of planning permission, to make an Order under section 209 of the Town and Country Planning Act 1971 and section 32 of the Mineral Workings Act 1951 to authorise the temporary stopping-up of the highways described in the schedule to this notice for a period of 5 years to enable minerals to be worked by service working.

During the 28 days from 14th January 1988 copies of the draft Order and the relevant plan may be inspected free of charge at all reasonable hours at the offices of Merthyr Tydfil Borough Council, Town Hall, High Street, Merthyr Tydfil.

Within the above-mentioned period of 28 days any person may by written notice to the Welsh Office, Highways Directorate, Roads Administration Division, Government Buildings Ty Glas Road, Llanishen, Cardiff CF4 5PL (quoting ref. WR15/5/233), object to
