TOWN AND COUNTRY PLANNING ACT 1971 SECTIONS 215 AND 216

**MINISTRY OF AGRICULTURE,
FISHERIES AND FOOD****DISEASES OF FISH ACT 1937 (AS AMENDED)**

Notice is hereby given that the Minister of Agriculture, Fisheries and Food, having reasonable grounds for suspecting that certain inland waters are infected areas, has made the Diseases of Fish (Designated Areas) (England) (No. 2) Order 1988.

The Order designates two areas for the purpose of Section 2 of the Diseases of Fish Act 1937, as amended by the Diseases of Fish Act 1983, and prohibits the taking of any live Atlantic salmon out of the areas without the previous consent in writing of the Minister of Agriculture, Fisheries and Food.

The Order came into force on 16th February 1988.
