PUBLIC HEALTH ACTS AND CLEAN AIR ACT

KIRKLEES METROPOLITAN COUNCIL

CLEAN AIR ACTS 1956 AND 1968
(as amended by Local Government Planning and Land Act 1980)

The Kirklees (Huddersfield No. 25 Moldgreen/Greenside) Smoke Control Order 1988

Notice is hereby given that the Kirklees Metropolitan Council in exercise of the powers conferred on them by section 11 of the Clean Air Act 1956 as amended by the Local Government Planning and Land Act 1980, propose to make the Kirklees (Huddersfield No. 25 Moldgreen/Greenside) Smoke Control Order 1988 declaring the area described in the Schedule hereto to be a Smoke Control Area.

Any person who will be affected by the Order may within 6 weeks of the date hereof make any objections to the Order in writing to the Chief Legal and Administrative Officer, Kirklees House, Market Street, Huddersfield HD1 2TG. (Ref: SMR/D81.032).

Subject to any exemptions provided by the Order and by virtue of section 11(4) of the Clean Air Act 1956, if, on any day after the Order has come into operation, smoke is emitted from a chimney of any building within the Smoke Control Area the occupier of that building shall be guilty of an offence and liable to a fine not exceeding £100 unless he proves that the emission of smoke was not caused by the use of any fuel other than an authorised fuel. The authorised fuels include anthracite coke and other carbonised fuels, gas and electricity.

If on any day after the Order has come into operation any person who acquires solid fuel other than an authorised fuel for use in a building within a Smoke Control Area or sells by retail any solid fuel other than an authorised fuel for delivery by him or on his behalf to a building in a Smoke Control Area shall be guilty of an offence and liable to a fine not exceeding £100 unless he can show that the building or fireplace was exempted by the Order or by virtue of section 11 of the Clean Air Act 1956.

It is anticipated that the Order will come into operation on 1st November 1988, or a later date as may be determined by the Local Authority.

The area bounded by Wakefield Road from the junction with Almondbury Bank in an easterly direction to the borough boundary at Waterloo Bridge at Tandem. Then following the borough boundary along Fenay Beck in a south-easterly direction to a point at the end of the embankment to the Yorkshire Traction Omnibus Depot and then turning right and crossing Penistone Road (A629) into Mitchell Avenue, Mitchell Avenue from its junction with Penistone Road to its junction with Fleminghouse Lane, Fleminghouse Lane from its junction with Mitchell Avenue to its junction with Fernside Avenue.
