Fishery Byelaw

This byelaw is in addition to the Authority's existing byelaws confirmed by the Minister and the effect is as indicated below:

Prohibition on Use of Lead Weights

No person shall on or after 1st July 1988 use any instrument to which is attached directly or indirectly any lead weight (except a weight of 0.06 grams or less, or one of more than 28.35 grams) for the purpose of taking salmon, trout, freshwater fish or eels in any waters within the Authority's area.
