#### HIGHWAYS ACT 1980

The A604 Catthorpe-Harwich Trunk Road (Thrapston to Brampion Section and Slip Roads) Supplementary Side Roads Order 198

The Secretary of State for Transport hereby gives notice that he proposes, in relation to the above-mentinoed new trunk road to be constructed by him between the A604 east of Thrapston, in the County of Northamptonshire and the A14 Trunk Road, west of Huntingdon, in the county of Cambridgeshire, to make under sectins 14 and 125 of the Highways Act 1980 an Order which will:

(a) authorise him:(i) to carry out the improvement of highways;

(ii) to stop-up highways, (iii) to construct new highways

(iv) to stop-up private means of access to premises, and (v) to provide new means of access to premises,

all on or in the vicinity of the route of the above-mentioned new trunk road to be constructed by him in pursuance of the A604 Catthorpe-Harwich Trunk Road (Thrapston to Brampton Section and Slip Roads) Order (No 2) 1987, and

(b) provide for the transfer of the said new highways to the highway authority specified in the Order as from the date on which he notifies the relevant authority that the new highway has been completed and is open for through traffic.
