

## ACQUISITION OF LAND ACT 1981

*The A406 London North Circular Trunk Road (Hanger Lane to Harrow Road Improvement) Compulsory Purchase Order (No ) 198**Tokyngton Recreation Ground*

The Secretary of State for Transport has prepared this draft compulsory order which he proposes to make. If made it will authorise the purchase of land which forms part of an open space as defined in the Acquisition of Land Act 1981, that is, land laid out as a public garden or used for the purposes of public recreation or a disused burial ground. This land is described in the First Schedule to this notice and is shown coloured pink on the map referred to in paragraph 4 below.

The Order will be subject to special parliamentary procedure unless the Secretary of State for the Environment gives a certificate under section 19(1) of the Act. He has been asked by the Secretary of State for Transport to certify under section 19(1) (a) that he is satisfied that other land has been or will be given in exchange for the open space, which is not less in area and is equally advantageous to any persons entitled to rights of common or other rights and to the public, and that the land given in exchange has been or will be vested in the persons in whom the open space was vested, subject to the like rights, trusts and incidents as attach to the open space. The land proposed to be given in exchange is described in the Second Schedule hereto and is shown coloured green on the maps referred to in paragraph 4 below.

The Secretary of State is required to give formal notice of his intention to issue a certificate before he reaches a decision, to give an opportunity for objections to be made. He hereby gives such notice. Any representations or objections in relation to this proposal should be made in writing and addressed to the Department of the Environment, Room 2543, Millbank Tower, 21-24 Millbank, London SW1P 4QU before 24th March 1988, quoting GLP 5006/10/1.

Maps showing the open space proposed to be purchased and the land proposed to be given in exchange may be seen, without payment, at the offices of the Department of Transport, Room C7/06, 2 Marsham Street, London SW1P 3EB and at the offices of the London Borough of Brent, Brent House, 349 High Road, Wembley, Middlesex; at the offices of the London Borough of Ealing, Technical Services' Department, 24 Uxbridge Road, London W.5; at the Tokyngton Public Library, Monks Park, Wembley, Middlesex; and at Ealing Central Library, 103 Ealing Broadway Centre, London W.5, at all reasonable hours.

The Secretary of State for the Environment may, if he considers it expedient, hold a public local inquiry into the matter.

## FIRST SCHEDULE

11,476 square metres of land shown on the plan numbered L7309.P.1418, forming part of the public open space known as Tokyngton Recreation Ground, situated to the north-west of the A406 North Circular Road between Harrow Road and Pitfield Way, comprising a landscaped area of grassland, footpaths and planting, and a grass bank.

A total of 11,700 square metres of land shown on the plans numbered L7309.P.1419 and L7309.P.1420, comprising the following:

- (i) 10,400 square metres of land to the north of Leicester Road adjoining Taylors Lane Power Station, and to the rear of Sladebrook High School and numbers 200-239 Brentfield Road;
- (ii) 1,300 square metres of land comprising disused tennis courts and associated buildings, situated to the rear of properties numbered 46-66 Village Way, 37-43 Elm Way and 2-16 The Rise.

## ROAD TRAFFIC REGULATION ACT 1984

*The A638 Trunk Road (Doncaster Road, Upton) (40 m.p.h. Speed Limit) Order 1988*

The Secretary of State for Transport hereby gives notice that he proposes to make an Order under sections 84(1) and (2) of the Road Traffic Regulation Act 1984. The effect of the Order will be that no person shall drive any motor vehicle at a speed exceeding 40 m.p.h. on that length of the A638 trunk road at Upton (known locally as Doncaster Road) in the district of Wakefield in the county of West Yorkshire, which extends from a point 50 metres north-west of Common Lane to a point 40 metres south-east of Wrangbrook Lane (including the roundabout at the junction of the trunk road with Back Lane and New Lane, Upton), a distance of approximately 1670 metres.

*The Stopping-Up of Highways (County of Hertfordshire) (No 2) Order 1988*

The Secretary of State for Transport hereby gives notice that, on the application of East Hertfordshire District Council, he has made an Order under section 209 of the above Act entitled "The Stopping-Up of Highways (County of Hertfordshire) (No. 2) Order 1988" authorising the stopping-up of part of Station Road, Ware, to enable residential development consisting of the refurbishment and partial demolition of a disused flour mill to provide a total of 81 dwellings to be carried out in accordance with planning permission granted to Adamflare Developments Limited by East Hertfordshire District Council.

The Order requires the provision of a new highway.
