

5. To suspend for the duration of this Order parts of Schedules 3, 7 and 9 of The County of Devon (Various Streets, Kingsbridge) (Traffic Regulation) Consolidation Order 1987 insofar as they relate to Fore Street between its junctions with Bridge Street and Duncombe Street.

Exceptions will be provided in the Order permitting waiting for the purposes of boarding and alighting, loading and unloading except as stated in paragraph 2, building and demolition, roadworks, the maintenance of essential services and for vehicles used by disabled persons in accordance with the Orange Badge Scheme.

The County of Devon (West Street, Tavistock) (Weight Restriction) Experimental Order 1988

HAVERING LONDON BOROUGH COUNCIL

Prohibition of right turn at Junction Road and Main Road, Romford

CALDERDALE BOROUGH COUNCIL
