Designation of Conservation Area

Notice is hereby given that the Richmondshire District Council have designated the area referred to in the Schedule to this Notice as a conservation area under section 277 of the Town and Country Planning Act 1971.

The effect of the designation is that:

- (a) No building in the conservation area may be demolished without obtaining Listed Building Consent from the Council. Exceptions to this rule are laid down in paragraph 97 of the Department of the Environment Circular 8/87 details of which are available from the Richmondshire Planning Department.
- (b) Anyone wishing to cut down, top, lop, uproot or destroy any tree in a conservation area shall give the Council 6 weeks notice of his intention in accordance with section 61A of the Act of 1971.
- (c) The Council will give special attention to the desirability of preserving or enhancing the character and appearance of the conservation area.

SCHEDULE

The Conservation Area comprises the whole of the land enclosed by the following boundaries to Quarry Hills House, Leyburn.

Starting at the north west corner, the north boundary is defined by the high stone wall extending along the south of the track between Quarry Hills House and Maythorne in an easterly direction to a point where it is intercepted by a post and rail fence marking the boundary to Leyburn Health Centre.

The east boundary of the site extends from this intersection in a southerly direction and comprises a combination of post and rail fence and stone boundary wall to a point where it intercepts with the stone retaining wall forming the north boundary to the Health Centre car park.

Turning to the west the boundary extends along the stone retaining wall to the vehicular access point to Quarry Hills House. The boundary then turns in a north westerly direction and then northerly following the high stone boundary wall which marks the east side of the footpath which lies between Brentwood and Quarry Hills House and terminates at the point where the boundary walls turns in an eastward direction.

HIGHWAYS ACT

Gwynedd County Council
Section 116 Highways Act 1980

Notice is hereby given that the County Council of Gwynedd, the highway authority for the district of Meirionnydd intend to make an application at the Dolgellau Magistrates' Court at Dolgellau, on the 10th May 1988, at 10.15 a.m. for an Order to stop up certain stretches of highways without retaining any footpath rights thereon and to stop up stretches of highways and retain footpath rights thereon. All of these sections of highways are situated near Ffridd Goch Ganol, Llanfachreth in the community of Brithdir and Llanfachreth in the district of Meirionnydd in the county of Gwynedd. The sections of highway to be stopped up without retaining any footpath rights thereon are as follows:

(a) A stretch of 715 metres of highway running (from its southernmost point) in a north-north-east direction and then at its mid point changing its course to run in a north-west direction. The stretch's southernmost point (A) lies where the private unfenced Road (which serves Ffridd Goch Ganol) leaves the County Unclassified Road. Its northernmost point (C) lies 76 metres north-west of the derelict dwelling known as Ffridd Goch Pen yr Allt.

(b) A stretch of 82 metres of highway running in an east-west direction. Its eastern point lies at Ffridd Goch Uchaf (D) and its western point (B) lies at the junction with the mid point of the highway referred to in paragraph (a) above.

(c) A stretch of 34 metres of highway running in an east-west direction and its eastern end (F) makes a junction with the northern end of the highway described in paragraph (1) below, and its western end (G) makes a junction with the southern end of the highway described in paragraph (2) below.

(d) A stretch of 94 metres of highway running in a north-west-south-east direction. The north-western end (L) makes a junction both with the southern end of the highway described in paragraph (e) below and the southern end of the highway described in paragraph (f) below. The south-eastern end (J) makes a junction with County Unclassified Road Numbered 584.

(e) A stretch of 90 metres of highway running in a north-south direction. The northern end (N) lies in deep forest. The southern end (M) makes a junction both with the northern end of the highway described in paragraph (3) below and the southern end of the highway described in paragraph (f) below.

(f) A stretch of 43 metres long highway running in a north-west-south-east direction. The north-western end (O) makes a junction with Public Footpath 61. The southern end (M) makes both a junction with the southern part of the highway described in paragraph (e) above and the northern end of their highway described in paragraph (3) below.

The section of highway that is to be stopped up but with the retention of footpath rights thereon is:

(1) A stretch of 120 metres of highway running in a general north-north-west-south-south-east direction. The southern end (E) makes a junction with the County Class III Road numbered 419 and on site there is a small wooden gate. The northern end (F) makes a junction with eastern end of the highway described (C) above.

(2) A stretch of 470 metres of highway running in a general direction of north-south. The northern end (D) makes a junction with the eastern portion of the highway described in paragraph (b) above. The southern end (G) makes a junction with the western end of the junction of the highway described in paragraph (c) above.

(3) A stretch of 245 metres of highway running in a general north-west-south-east direction. The south-eastern end (L) makes a junction with the northern-western end of the highway described in paragraph (d) above. The north-western end (M) makes a junction with both the southern part of the highway described in paragraph (e) and also the southern part of the highway described in paragraph (f).

A plan showing the lengths of highway referred to above is annexed hereto.
