UNIVERSITIES OF OXFORD AND CAMBRIDGE ACT 1923

A Statute made by the Governing Body of Christ's College, in the University of Cambridge on 2nd February 1988, amending Statutes D & E has been submitted for the approval of Her Majesty in Council, and notice of its having been so submitted is published in accordance with the provisions of the Universities of Oxford and Cambridge Act 1923. The Statute makes provision in relation to the termination of certain Fellowships and Lectureships.

WELSH OFFICE

The Secretary of State for Wales hereby gives notice that he proposes to make an Order under section 211 of the Town and Country Planning Act 1971 to authorise the stopping-up of the highway described in the Schedule to this notice in the interests of the safety of users of the main highway which is to be constructed.

WR15/5/260), object to the making of the Order, stating the grounds for objection. In the preparation of an objection and statement of grounds of objection, it should be borne in mind that the substance of any objection or representation may be communicated to other people who may be affected by it.

SCHEDULE

(All distances are approximate)

The highway to be stopped up is at Dowlais in the County of Mid Glamorgan. It is that length of highway known as Walter Street which extends from its junction with Upper Elizabeth Street in a north-westerly direction for a distance of 30 yards, excluding that length of footway adjoining the Carmarthen Arms Public House which extends from Elizabeth Street for a distance of 23 yards.

TOWN AND COUNTRY PLANNING ACT 1971

The Secretary of State for Transport hereby gives notice that he has made an Order under section 209 of the above Act entitled "The Stopping-Up of Highways (County of North Yorkshire) (Selby No. 1) Order 1988", authorising the stopping-up of Harper Street, Selby.
