MID GLAMORGAN COUNTY COUNCIL

Mid Glamorgan County Council (Pritchard Street and Un-named Road, Tonyrefail) (Variation) and (Prohibition of Waiting) Order 1988.

Notice is hereby, given that the Mid Glamorgan County Council propose to make an Order under sections 1, 2 and 4 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 the effect of which will be as follows:

(i) to vary the provisions of the "Glamorgan County Council (Pritchard Street, Tonyrefail) (Prohibition of Waiting) Order 1972", by deletion of the reference in Article 1 of that Order, to the northern side of Pritchard Street from a point 15 metres (16 yards) east of its junction with Mill Street eastwards to the common boundary of Nos. 13-15 Pritchard Street.

(ii) to vary the provisions of the "Glamorgan County Council (Pritchard Street, Tonyrefail) (Prohibition of Waiting) Order 1972", by deletion of the reference in Article 2 of the Order to the northern side of Pritchard Street from a point in line with the common boundary of the premises known as Nos. 13-15 Pritchard Street to the eastern boundary of the premises known as 65 Pritchard Street, Tonyrefail.

(iii) to prohibit the waiting of vehicles at any time on the following lengths of road:

(a) *Pritchard Street*, Tonyrefail, on both sides from its junction with the eastern side of Mill Street eastwards for a distance of 15 metres (16 yards).

(b) *Pritchard Street*, Tonyrefail, on both sides from the western side of its junction with the un-named road (known locally as Doctor's Hill) between Nos. 65 and 67 Pritchard Street westwards for a distance of 15 metres (16 yards).

(c) *Pritchard Street*, Tonyrefail, on both sides from the eastern side of its junction with the unnamed road (known locally as Doctor's Hill) between Nos. 65 and 67 Pritchard Street eastwards for a distance of 15 metres (16 yards).

(d) un-named road between Nos. 65 and 67 Pritchard Street, Tonyrefail (known locally as Doctor's Hill), both sides from its junction with the northern side of Pritchard Street northwards for a distance of 15 metres (16 yards).

Exemptions will be provided in the Order to enable medical practitioners and veterinary surgeons to visit while "on call" and for the purposes of boarding, alighting, loading and unloading, building and road works, the maintenance, improvement, reconstruction, inspection or survey of the sides of lengths of roads, the maintenance of essential services, weddings, funerals and the delivery or collection of postal packets by vehicles in the service of the Post Office. Disabled person's vehicles displaying the relevant disabled person's badge will be allowed to wait for up to 2 hours with return prohibited within 1 hour.

A copy of the proposed Order, a statement of the Council's reasons for proposing to make the Order, and a map showing the sides of lengths of roads to which the proposed Order relates may be inspected at the offices of the Taff Ely Borough Council, Municipal Buildings, Pontypridd, and at the Mid Glamorgan County Hall, Cathays Park, Cardiff, during normal office hours.

Mid Glamorgan County Council (Gadlys Pit Access Road, Gadlys, Aberdare) (Prohibition and Limitation of Waiting) Order 1988

Notice is hereby given that the Mid Glamorgan County Council propose to make an Order under sections 1, 2 and 4 of the Road Traffic Regulation Act 1984, the effect of which will be:

(i) to prohibit the waiting of vehicles at any time on the lengths of roads and side of length of road as described in Schedule 1 to this notice,

(ii) to prohibit the waiting of vehicles between the hours of 8 a.m. to 6 p.m. on the side of length of road described in Schedule 2 to this notice.

Exceptions will be provided in the Order to enable medical practitioners and veterinary surgeons to visit while "on call" and for the purposes of boarding, alighting, loading and unloading, building and roadworks, the maintenance of essential services, weddings, funerals and the delivery or collection of postal packets by vehicles in the service of the Post Office. Northern side of the un-named road to the rear of the Crown Buildings, Green Street, Aberdare, from a point 20 metres (22 yards) east of its junction with the Gadlys Pit Access Road eastwards for a distance of 65 metres (70 yards).
