(d) the use of any vehicle or of any animal or the wearing of fancy dress or other costume, wholly or mainly for the purpose of advertising, in the length of street referred to in sub-paragraph (a) above will be prohibited.

The prohibition referred to in paragraphs 2(a) and 2(b) above will not apply in respect of anyting done with the permission or at the direction of a police constable in uniform or in certain circumstances, e.g. the picking up or setting down of passengers; the carrying out of statutory powers or duties; the taking in of petrol, etc., from roadside petrol stations; to licensed street traders, etc

The prohibition referred to in paragraph 2(i) above will not apply to:

(i) Anyting done with the permission or at the direction of a Police Constable in uniform, or

(ii) Any person who causes any vehicle to proceed in accordance with any restriction or requirement indicated by traffic signs placed pursuant to section 66 or section 67 of the Road Traffic Regulation Act 1984.

The Order provides that in pursuance of section 10(2) of the Road Traffic Regulation Act 1984, the Director of Development for the time being, or some person authorised in that behalf by him, may, if it appears to him or that person essential in the interests of the expeditious, convenient and safe movement of traffic or preserving or improving the amenities of the area through which any road affected by this Order runs, modify or
