Notice is hereby given that on 8th March 1988 Dermot F. Byrne (Assistant General Manager) in accordance with the power delegated to him by the Planning and Economic Development Committee of the Council confirmed the above-named Order.

The effect of the Order as confirmed is to extinguish the public rights of way described in Part I of the Schedule to the Order and create alternative highways in lieu described in Part II of the Schedule thereto.

A copy of the confirmed Order and the map contained in it has been deposited at Town Hall, Harlow and may be inspected free of charge at Town Hall, Harlow between 8.30 a.m. and 5 p.m. from Mondays until Fridays. Copies of the Order and map may be obtained free of charge.

This Order becomes operative as from the date of confirmation but if any person aggrieved by the Order desires to question the validity thereof or of any provision contained therein on the ground that it is not within the powers of the Town and Country Planning Act 1971, or on the ground that any requirement of that Act or any regulation made thereunder has not been complied with in relation to the confirmation of the Order he may under section 244 of the Town and Country Planning Act 1971 within 6 weeks from the date of publication of this notice make application for the purpose to the High Court.

### NEW FOREST DISTRICT COUNCIL

*New Forest District Council  
The Designation of The Buckland Conservation Area,  
Lymington, Hampshire*

Notice is hereby given that in pursuance of their powers under section 277 of the Town and Country Planning Act 1971 The District Council of the New Forest on 10th February 1988 designated as a Conservation Area an area of land at Buckland, Lymington, Hampshire.

The Designated Conservation Area includes all that land enclosed by a continuous boundary on the map referred to below which boundary is briefly described as running from the Tollhouse Inn, Southampton Road north to Passford Hill Cottage thence south-west to the Water Tower, Sway Road, thence south to a point on the northern boundary of Buckland School thence east to the west side of Southampton Road.

With every few exceptions, buildings within a Conservation Area may not be demolished except with the consent of the Local Planning Authority nor (again with very few limited exceptions) may trees be topped, lopped, felled, and rooted or wilfully damaged or destroyed unless notice of proposed action has been given to the Local Planning Authority and permission to proceed has been received from them or they have failed to take conclusive action regarding the notice within 6 weeks of the time it was served. Trees already included in Tree Preservation Orders are not subject to this procedure but are subject instead to the more stringent requirements of the appropriate Order.

A map showing the precise extent of the Conservation Area is available for public inspection between the hours of 9 a.m. and 4.30 p.m. Monday to Friday at the Planning Department, Appletree Court, Lyndhurst and at The Town Hall, Lymington. A copy of the map will also be held by the Clerk to Lymington and Pennington Town Council.

Further information and details of policy may be obtained from the Chief Planning Officer at Appletree Court, Lyndhurst, Hampshire.
