The Hertfordshire (Footpath No. 47) (Part) (Parish of Ardeley)
Diversion Order 1988

Notice is hereby given that the above-named Order made on 16th March 1988 is about to be submitted to the Secretary of State for the Environment for confirmation or to be confirmed as an unopposed Order by the Hertfordshire County Council.

The effect of the Order if confirmed without modification will be to divert the public right of way running over the land situate at Cromer in the parish of Ardeley shown by an unbroken line on the Order map and described in Part A of the Schedule hereto to a line shown by a broken line on the Order map and described in Part B of the Schedule hereto.

A copy of the Order and the map contained in it has been deposited and may be inspected, free of charge, during normal opening hours at the offices of the Hertfordshire County Council, Room 204, County Hall, Hertford, the East Hertfordshire District Council, Council Offices, the Causeway, Bishops Stortford and at Ardeley Parish Council, Burnside, Cromer, Stevenage.

Any representation or objection with respect to the Order may be sent in writing to the County Secretary, Hertfordshire County Council, County Hall, Hertford before Tuesday, 19th April 1988 and should state the grounds on which it is made.

If no representations or objections are duly made or if so made are withdrawn the Hertfordshire County Council may, instead of submitting the Order to the Secretary of State for the Environment, themselves confirm the Order. If the Order is submitted to the Secretary of State, any representations and objections which have been duly made and not withdrawn will be transmitted with the Order.
