ROAD TRAFFIC ACTS

BRIGHTON BOROUGH COUNCIL

The Brighton (Bear Road-Riley Road) (Prohibition of Waiting Order 1975) (Amendment No. 3) Order 1988

The Brighton Corporation (Various Roads) (Prohibition of Waiting No. 1 Order 1973) (Amendment No. 3) Order 1988

The Brighton (Disabled Drivers Parking Places Consolidation Order 1981) (Amendment No. 25) Order 1988

Notice is hereby given that on 18th March 1988 Brighton Borough Council, acting as agents for East Sussex County Council, made the above Orders under the Road Traffic Regulation Act 1984, the effect of which is as follows:

- Bear Road:* Introduction of no waiting at any time on south side of Bear Road from 45 feet (13.5 metres) east of Newmarket Terrace eastwards for 246 feet (75 metres); this is a reduction in length of the original proposal.
- Newmarket Terrace:* The existing no waiting at any time, extending southwards from Bear Road, to be reduced from 45 feet to 30 feet (9 metres).
- Montague Street:* Introduction of no waiting at any time on north side of Montague Street, from 138 feet (42 metres) west of Montague Place, westwards for 72 feet (22 metres).
- Disabled Drivers Parking Places:* New bays will be provided as follows:

Outside 95 Ladysmith Road, 48 Whitehawk Way and 3 Winchester Street, outside entrance to Nos. 13-16 Hornby Place, and opposite No. 49 Maresfield Road.

Existing bays outside 36 Brading Road and 26 Clyde Road to be revoked.

Exceptions to the prohibitions and restrictions of waiting will be included in respect of disabled persons' vehicles and to permit picking up and setting down of passengers, loading and unloading goods, road works and the maintenance of essential services.

Copies of the Orders, which will come into operation on 30th March 1988, and maps showing the roads affected, may be examined at the Enquiry Office, Town Hall, Brighton, between the hours of 9 a.m. and 4 p.m. on Mondays to Fridays.

If you wish to question the validity of the Orders, or of any provisions contained in them on the grounds that they are not within the powers conferred by the Road Traffic Regulation Act 1984, or on the grounds that any requirement of that Act or of any regulation made under it has not been complied with in relation to the Orders, you may, within 6 weeks from 18th March 1988, apply to the High Court for this purpose.
