Anglian Water Authority (Bircham Newton Borehole) Order 1988

Notice is hereby given that it is the intention of the Anglian Water Authority (hereinafter referred to as "the Authority") to make application to the Secretary of State for the Environment for an Order under Section 23 of the Water Act 1945.

The general effect of the Order will be to empower the Authority to continue and maintain a pumping station and borehole in the Parish of Bagthorpe in the County of Norfolk being part of the enclosure numbered 5260 in the said parish on the 1:2500 Ordnance Survey Map of Norfolk Sheet Number TF 73SE (Edition of 1980) and to authorise the Authority to construct and maintain all such additional wells boreholes adits and headings as may be necessary or expedient for augmenting or improving the supply of water obtainable by means of the said borehole.

NOTICE OF PROPOSALS TO VARY A LICENCE TO ABSTRACT WATER

Notice is hereby given that the Severn-Trent Water Authority (hereinafter called "the Authority") whose head office is at Abelson House, 2297 Coventry Road, Sheldon, Birmingham B26 3PU has formulated proposals for varying its licence serial number 18/54/10/118 which authorises abstraction from nine well collecting chambers at North Kilworth and Welford, Near Husbands Bosworth, Leicestershire at National Grid References SP 627 854; SP 626 852; SP 628 848; SP 622 844; SP 622 843; SP 618 841; SP 623 845; SP 636 820 and SP 639 816 and a stream intake at Lodge Farm, Husbands Bosworth at National Grid Reference SP 628 854.

The proposed variation is (i) to increase the maximum annual authorised quantity from 110,000,000 gallons to 153,981,522 gallons (700,000 cubic metres) (ii) to remove the abandoned stream intake source at NGR SP 628 854 from the licence and (iii) to delete the special condition on the licence which is no longer relevant.

A copy of the proposals in the form of a draft varied licence and of any map, plan or other document prepared in connection with them may be inspected by the public free of charge at the Leicester Water Centre, Gorse Hill, Anstey, Leicester at all reasonable hours during the period beginning on 6th April and ending on 4th May 1988 inclusive.

At the expiry of the said period, the Authority will be entitled to pass a resolution by virtue of which the licence shall be deemed to be varied unless the Secretary of State for the Environment, either in consequences of any representations made with respect to the proposals, or otherwise, requires an application for the variation of the licence to be made to him.

NOTICE OF PROPOSALS FOR A NEW LICENCE TO ABSTRACT WATER
