### Metropolitan Borough of Wirral Traffic Regulation Orders

Notice is hereby given that Wirral Borough Council proposes to make the following Orders under sections 1-4 of the Road Traffic Regulation Act 1984:

#### Croft Drive and Various Streets, Moreton Weight Restriction) Order 1987

The effect of which will be to prohibit any person from causing any motor vehicle, the gross laden weight of which exceeds 7.5 tonnes, to proceed in any of the lengths of road specified, except to obtain access to premises in those roads:

Hoylake Road and Various Streets, Moreton (Prohibition of Waiting) Order 1984 (Amendment No. 1) 1988

The effect of which will be to prohibit the waiting of vehicles at any time along the lengths and sides of roads specified:

Side(s)

- 1. Hoylake Road from a point 45 feet (13.7 metres) east of the east side of its junction with Joan Avenue to a point 45 feet (13.7 metres) west of its westerly junction with Holt South Avenue.
- 2. Hoylake Road from a point 45 feet (13.7 metres) east of the east side of its junction with Joan Avenue for a distance of 220 feet North (67.0 metres) in an easterly direction.
- 3. Rosslyn Drive from its junction with Hoylake Road for a distance of 45 feet (13.7 East metres) in a southerly direction.

Craven Street, Birkenhead (Prohibition of Waiting) Order 1987

The effect of which will be tuy rohibit the waiting of vehicles at any time on both sides of Creven Street, 33 feet (10.0 metres) from its junction with Conway Street in a south-westerly direction to its junction with Craven Close.

# The County Borough of Bithenhead (Balls Road and Various Streets) (Prohibition of Waiting) Order 1971 (Amendment No. 1) 1987

The effect of which will be to prohibit the waiting of vehicles at any time along the lengths and sides of roads specified:

- 1. Slatey Road from a point 50 metres north of Both the north side of its junction with Balls Road to its junction with Balls Road.

# Passage between Deveraux Drive and Annesley Road, Wallasey (Prohibition of Driving) Order 1987

The effect of which will be to prohibit any person from causing any vehicle to enter or leave the passage between Nos. 50 and 52 Deveraux Drive from its junction with Deveraux Drive for a distance of 20 metres (65 feet) in a north-easterly direction.

Where appropriate exceptions will be provided in the Orders to permit the picking up and setting down of passengers, loading and unloading of goods, maintenance of roads, supply of gas, electricity and water in pursuance of statutory powers and duties and disabled persons' parking and hackney carriages to wait on authorised stands.
