#### ISLINGTON LONDON BOROUGH COUNCIL

The Islington (Waiting and Loading Restriction) (Amendment No. 63) Order 1988

Relating to Piper Close N.7.

Notice is hereby given that the Islington Borough Council on 22nd March 1988 made the above-mentioned Order under section 6 of the Road Traffic Regulation Act 1984 as amended by the Local Government Act 1985.

The general effect of the Order will be to amend the Islington (Waiting and Loading Restriction) Order 1976, so that in the lengths of Piper Close specified in the Schedule to this notice:

- (a) waiting by vehicles (otherwise than for the purpose of delivering or collecting goods or loading or unloading a vehicle) will be prohibited between 8 a.m. and 6.30 p.m. on Mondays to Saturdays inclusive.
- (b) waiting by vehicles for the purpose of delivering or collecting goods or loading or unloading a vehicle will be prohibited for a period of more than 20 minutes in the same place between 11 a.m. and 6.30 p.m. on Mondays to Saturdays inclusive unless otherwise prohibited.
- (c) the sale or offer for sale of goods from a vehicle will be prohibited, except on a Sunday, unless there is in force a valid licence issued by Islington Borough Council or the goods are immediately taken into or delivered at premises adjacent to the vehicle from which the sale is effected.
- (d) the use of any vehicle or of any animal or the wearing of fancy dress or other costume, wholly or mainly for the purposes of advertisement will be prohibited.

The prohibition referred to in paragraph 2(a) and 2(b) above would not apply in respect of anything done with the permission or at the direction of a police constable in uniform or in certain

or at the direction of a police constable in uniform or in certain circumstances, e.g., the picking up or setting down of passengers; the carrying out of statutory powers or duties; the taking in of petrol, etc., from roadside petrol stations; licensed street traders. A copy of the Order which comes into effect on 26th March 1988 details of the measures referred to in paragraph 2(a) above, of the Islington (Waiting and Loading Restriction) Order 1976 (and of the Orders which have amended the Order) and of the Council's statement of reasons for making the Order can be inspected during normal office hours on Mondays to Fridays inclusive, until the expiration of a period of 6 weeks from the date the Order was made at the following locations:
