Mariners Lane/Lily Terrace Permit-Parking/Waiting Restrictions

The proposal is to introduce permit holders parking in Mariners Lane and Lily Terrace and to introduce waiting restrictions so that the amenity of the area will be improved for residents.

The effect of the scheme would be as follows:

- (a) the provision of thirteen defined permit only parking places in Mariners Lane and six defined permit only parking places in Lily Terrace.

No waiting 8 a.m. to 6.30 p.m. Monday to Saturday in Horns Lane with the exception of:

(a) two parking bays restricted to waiting limited to one hour

(b) eleven parking bays allocated to unrestricted parking

The proposals would be brought into effect by a Traffic Regulation Order which would be known as "The City of Norwich (Central Area Traffic Control) (Consolidation) Amendment (No.) Order, 198 ".

The Order which prohibits entry except for access to Horns Lane would be revoked.

Exceptions to the regulations would allow waiting to pick up or set down passengers, for the loading and unloading of goods, by disabled persons' vehicles and for the necessary waiting in connection with building operations, postal services and for the maintenance of all roads and all services.
