

- d. 11,225 square metres of pasture land on the east of Cobbs Lane and north west of Middlewich Road (A530) and numbered plot 9;
- e. 190 square metres of pasture land on the east of Cobbs Lane and north east of Alvaston Farm and numbered plots 9A, and 9C;
- f. 1,220 square metres of pasture land north west of Middlewich Road and on the west of the unnamed road on the south of property known as Pane House Hostel and numbered plot 9D;
- g. 4,170 square metres of pasture land on the north of Middlewich Road and east of Pane House Hostel and numbered plot 12;
