Proposed Stopping Up of a Highway at Chadderton, Oldham

The Secretary of State for Transport hereby gives notice that on the application of Oldham Metropolitan Borough Council on behalf of Mrs. B. K. Stewart, he proposes to make an Order under section 209 of the above Act, to authorise the stopping up of part of the width of an unnamed passageway off Middleton Road, Chadderton and adjacent to No. 1163 Middleton Road, to enable development consisting of the construction of a side garden and garage to be carried out in accordance with planning permission granted to B. K. Stewart by Oldham Metropolitan Borough Council under Part III of the said Act.
