The A40 Trunk Road (Western Circus Junction Improvement) Compulsory Purchase Order (No. ) 198

Notice is hereby given that the Secretary of State for Transport in exercise of the powers conferred on him by the abovementioned Acts has prepared a draft compulsory purchase order, entitled as above, which he proposes to make, authorising him to purchase compulsorily the land described in the schedule hereto for the purpose of:

(a) the construction of new trunk roads in the London Boroughs of Ealing and Hamersmith and Fulham in pursuance of the A40 Trunk Road (Western Circus Junction Improvement, Trunk Road and Slip Roads) Order

(b) the construction and improvement of highways and the provision of new means of access to premises in the London
Boroughs of Ealing and Hammersmith and Fulham in
pursuance of the A40 Trunk Road (Western Circus
Junction Improvement, Side Roads) Orde 198; and
(c) use by the Secretary of State in connection with such
construction and improvement of highways and the
execution of other works mentioned above.

Copies of the draft compulsory purchase order and of the plan referred to therein, together with copies of the published drafts of the above-mentioned Trunk Road and Slip Roads Order and Side Roads Order (with their accompanying plans), have been deposited and may be seen at all reasonable hours from 7th

Any objection to the draft compulsory purchase order must be made in writing and addressed to the Secretary of State at the Department of Transport, Room C8/04, 2 Marsham Street, London SW1P 3EB not later than 16th June, 1988 and should state the grounds of objection and quote the reference GLRT79/10/5010/26. In the preparation of an objection and the statement of grounds of objection it should be borne in mind that the substance of any objection or representation may be that the substance of any objection or representation may be communicated to other people who may be affected by it.
