  - (a) authorise him
    - (i) to carry out the improvement of highways,

    - (v) to provide new means of access to premises,
  - all on or in the vicinity of the routes of the new trunk roads mentioned in paragraph 1 above and to be constructed by him in pursuance of the A604 Catthorpe-Harwich Trunk Road (Kettering to Thrapston section and Slip Roads) Order 1987; and
  - (b) provide for the transfer of the said new highways to the County Council of Northamptonshire as from the date on which he notifies the Council that the new highways have been completed and are open for through traffic.
