## NOTICE OF PUBLIC PATH ORDER

## HIGHWAYS ACT 1980

*Borough Council of Gateshead (unnamed footpaths Reservoir Street area Wardley) Public Path Extinguishment Order 1988*

Notice is hereby given that, 4th July 1988 is about to be submitted to the Secretary of State for the Environment for confirmation or to be confirmed as an unopposed Order by the Borough Council of Gateshead.

The effect of the Order, if confirmed without modifications, will be to extinguish the public rights of way extending:

- (i) from the former Reservoir Street Wardley in a westerly direction for approximately 184 metres; and
- (ii) from the former School Site in a south westerly direction for approximately 50 metres.

A copy of the Order and the map contained in it has been deposited and may be inspected free of charge at the:-

If no representations or objections are duly made or if any so made are withdrawn, the Borough Council of Gateshead may, instead of submitting Order to the Secretary of State for the Environment confirm the Order itself. If the Order is submitted to the Secretary of State any representations and objections which have been duly made and not withdrawn will be submitted with the Order.
