(2) *The Norfolk County Council (Boundary Junction, Norwich) (One-way) Order 1987.*

To prohibit the driving of any vehicle in the following lengths of road, otherwise than in the direction specified:

*Direction of Traffic*

*New Link Road*, between Reepham Road and Cromer Road, from west to east.

*Reepham Road*, between Boundary Road and New Link Road, from south-east to north-west.

*Cromer Road*, between New Link Road and Mile Cross Lane, from north to south.

*Slip Road*, between Cromer Road and Reepham Road, from east to west.

(3) *The Norfolk County Council (Boundary Junction, Norwich) (Prohibition of Right-hand Turn) Order 1987.*

To prohibit any vehicle proceeding along Boundary Road from making a right-hand turn into Aylsham Road.

**WEYMOUTH AND PORTLAND BOROUGH COUNCIL**

*The Borough of Weymouth and Portland (Prohibition of Driving) (Amendment) Order 198*

Notice is hereby given that the Borough Council of Weymouth and Portland propose to make the above-mentioned Order acting on behalf of the Dorset County Council in pursuance of arrangements made under section 101 of the Local Government Act 1972 and in exercise of the Dorset County Council's powers under sections 1(1) and (2), 2(1) to (3) and 3(2) of the Road Traffic Regulation Act 1984, and with the consent of the Secretary of State for Transport under Part II of Schedule 9 to the Act of 1984, the effect of which will be:

- (1) Save as provided in Article 2 of this Order, no person shall cause or permit any vehicle to proceed in Nothe Parade.
- (2) Nothing in Article 1 shall render it unlawful subject to the restrictions contained in Article 3 to cause or permit any motor vehicle to proceed in Nothe Parade:
  - (i) to enable the vehicle to gain access to premises in Nothe Parade;
  - (ii) to enable the vehicle when hauling a boat trailer, whether loaded or unloaded, to gain access to the dinghy park;
  - (iii) to enable the vehicle to gain access to the Stone Pier Refreshment Kiosk for the purposes of maintenance and deliveries;
  - (iv) to enable the vehicle to be used for the purpose of delivering or collecting postal packets as defined in section 87 of the Post Office Act 1953, as amended by the Post Office Act 1969;
  - (v) to enable the vehicle if it cannot conveniently be used for such purpose in any other road to be used on connection with any building operation or demolition, the removal of any obstruction to traffic, the maintenance, improvement or reconstruction of the road or the side of road so referred to, or the laying, erection, alteration or repair in or near the said road or the said side of road of any sewer or of any main, pipe or apparatus, for the supply of gas, water or electricity or of any telegraphic line as defined in the Telecommunications Act 1984;
  - (vi) to enable the vehicle, if it cannot conveniently be used for such purpose in any other road, to be used in connection with statutory powers or duties.

(3) Nothing in Article 2 shall apply to any vehicle:

- (i) the laden weight of which exceeds 2 tonnes;
- (ii) the width of which, inclusive of any load on the vehicle, exceeds 2.4 metres

provided that nothing in this Article shall apply to any vehicle used in relation to Fire Brigade, Police and Ambulance purposes.

And provided that an access exemption shall apply to the properties situated between the junction of No. 16 Nothe Parade and No. 24 Hope Street and the slipway.

Further, in the event that consent is first obtained from Barrett Marine Services (or the owner for the time being) any vehicle exceeding 2 tonnes laden weight may cross the wooden bridge adjacent to the premises occupied by W. L. Bussell and/or their successors in title and situated at the west end of Nothe Parade, provided the laden weight of the vehicle does not exceed 4 tonnes and provided that the vehicle is confined to the centre of the bridge when crossing, and that its track width does not exceed 1.6 metres.

TOWN AND COUNTRY AMENITIES ACT 1974

#### *Conservation Areas in Gosport*

Notice is hereby given that Gosport Borough Council has designated the following area in Gosport as a Conservation Area and extended the existing High Street Conservation Area pursuant to section 277 of the Town and Country Planning Act 1971 (as amended):

- (1) *Rowner*. The area includes Rowner Church, Middle Barn Cottage, Church Cottage, the Parish Centre and Rectory together with a significant area of public open space and the area of woodland copse immediately to the north of Rowner Road including the Texaco Filling Station.
- (2) *Extension of High Street Conservation Area*. The area includes the Gosport Museum Building, Nos 1-4 High Street, the Ritz Cinema, the Gosport Conservative Club, No. 92-93 North Street, Nos 9, 13 and 17 Seahorse Walk, Nos 6-12 (even) Seahorse Walk and "The Fox" Public House.

The above descriptions of the Conservation Areas are in general terms only; plans showing the exact extent of the Conservation Areas are deposited at the Town Clerk and Chief Executive's Department, Town Hall, High Street, Gosport, and may be inspected by the public between the hours of 9 a.m. to 5 p.m. on any weekday (excluding Saturday), and the Planning Division of the Department of Technical Services at the Town Hall will be pleased to advise whether particular properties are within the Conservation Areas and to supply further information generally.

The general effect of the designation of the Rowner Conservation Area and extension to the High Street Conservation Area is as follows:

- (a) The Local Planning Authority when determining applications for planning permission will have regard to the need to conserve and enhance the appearance and character of the area.
- (b) No building (or part of a building) in the area may be demolished without the consent of the Local Planning Authority except in those (mainly minor) cases exempted by direction of the Secretary of State for the Environment. Consent to demolition may be applied for separately, or as a specific part of a planning permission application for redevelopment. In assessing whether consent should be given for demolition, the Authority will have regard to the importance of the building to the character or appearance of any part of the Conservation Area. A list of those descriptions of demolitions which have been exempted by the Secretary of State, and so can be carried out without consent, is deposited for inspection with the plans of the Conservation Area referred to in (2) above.
- (c) No tree in the Conservation Area may be cut down, topped, lopped, uprooted, wilfully damaged or wilfully destroyed without the consent of the Local Planning Authority and a duty is placed on landowners to replace trees which are destroyed or die unless the Authority dispense with this requirement in a particular case.
- (d) Arrangements will be made by the Council for publicising all significant planning applications in the Conservation Area, so as to enable the public to submit comments to the Local Planning Authority before they make their decision on the applications.

The Conservation Areas have been designated because of their special architectural or historic interest and the Council intends to prepare in the future schemes for the preservation and enhancement of the Conservation Areas and there will be public consultation before such schemes are implemented.
