HARBOURS ACT 1964

Boston Harbour Revision Order

Notice is hereby given that application has been made to the Secretary of State for Transport (hereinafter referred to as "the Secretary of State") by the Boston Borough Council ("the Council") for the making of a Harbour Revision Order under section 14 of the Harbours Act 1964.

The following is a concise summary of the purposes of the proposed Order:

- (1) To designate Port of Boston Limited as the harbour authority for the Boston port, harbour and dock as from the day after the day on which expires a period of four weeks beginning with the date on which the Order comes into force.
- (2) To transfer to and vest in Port of Boston Limited, on the day after the day on which expires a period of four weeks beginning with the date on which the Order comes into force, the Boston port, harbour and dock undertaking of the Council together with all statutory and other powers and duties conferred or imposed on the Council and all rights, interests and privileges presently vested in or enjoyed by the Council in relation to the said undertaking.
- (3) To amend the application of the Harbours, Docks and Piers Clauses Act 1847 to the undertaking.
- (4) To repeal certain provisions of an Act of 7 & 8 Geo. 4 ch.lxxix, an Act of 5 Victoria Session 2 ch.lx, the Boston Docks Act 1881 and the Boston Corporation Act 1935 relating to the said undertaking.

A copy of the draft Order which accompanied the application has been deposited at the office of the under-mentioned Chief Executive of the Council where it may be seen at all reasonable hours.

Any person who desires to make to the Secretary of State objection to the application should do so in writing addressed to the Secretary, Department of Transport, Marine Directorate, Room 1-12 Sunley House, 90-93 High Holborn, London WC1V 6LP, quoting ref. P89/3/0247, and stating the grounds of the objection, within 42 days from the date at the foot of this notice. Notice of application to vary a licence to abstract water

SELBY DISTRICT COUNCIL

CLEAN AIR ACT 1956

The Thorpe Willoughby Smoke Control Order 1988

Notice is hereby given that the district council of Selby, in exercise of the powers conferred on them by section 11 of the above-mentioned Act, as amended by section 1 and Schedule 2 of the Local Government, Planning and Land Act 1980, proposed on 7th July 1988, to make an Order entitled Brayton Smoke Control Order 1988, declaring the area described in the Schedule hereto to be made a smoke control area.

Subject to the exemptions provided by the Order and by virtue of section 11(4) of the Clean Air Act 1956, if, on any day after the Order has come into operation, smoke is emitted from a chimney of any building within the Smoke Control Order area, the occupier of that building shall be guilty of an offence and liable to a fine not exceeding £400 unless he proves that the emission of smoke was not caused by the use of any fuel other than an authorised fuel. The authorised fuels include anthracite, coke and other carbonised fuels, gas and electricity.

Subject to the provisions of section 9 of the Clean Air Act 1968, any person who acquires for use in a smoke control area any solid fuel other than an authorised fuel shall be guilty of an offence and liable to a fine not exceeding £400.

If made, the Order will come into operation on 1st September 1989, or at a later date determined by Selby District Council.

Copies of the draft Order and the map referred to therein may be inspected free of charge at the Civic Centre, Portholme Road, Selby, at all reasonable times during the period of 6 weeks from 21st July 1988.

Within the said period any person who will be affected by the Order may, by notice in writing to J. C. Edwards, B.A. (Hons.), Chief Executive and Clerk of the Council, Selby District Council, Civic Centre, Portholme Road, Selby YO8 0SB, object to the making of the Order.
