#### **CLEAN AIR ACT 1956**

Nuneaton and Bedworth Borough Council Smoke Control Order No. 24 - Nuneaton Sunnyside

Notice is hereby given that the Nuneaton and Bedworth Borough Council in exercise of powers conferred on them by section 11 and Schedule 1 of the above-mentioned Act (as amended by the Local Government Planning and Land Act 1980) propose to make an Order entitled the Nuneaton and Bedworth Borough Council Smoke Control Order Number 24 – Nuneaton Sunnyside declaring the area described in the Schedule hereto to be a smoke control area.

In the case of any other building the maximum fine is £2,000. The authorised fuels include, anthracite, coke and other carbonised fuels, gas and electricity.
