TREASURY

TENDERS FOR TREASURY BILLS

The Lords Commissioners of Her Majesty's Treasury hereby give notice that Tenders will be received at the Securities Office, Bank of England, Threadneedle Street, on Friday 22nd July 1988 at 1 p.m. for Treasury Bills to be issued under the Treasury Bills Act 1877 and the National Loans Act 1968, to the amount of £100,000,000.

NORFOLK COUNTY COUNCIL

Norfolk County Council Proposed Experimental Pedestrianisation Scheme—Market Place, Great Yarmouth

Notice is hereby given that the Norfolk County Council have made the following Orders under the Road Traffic Act 1984, for the experimental pedestrianisation of the Market Place, Great Yarmouth. The Orders will remain in force, initially, for a period of 6 months. The Orders are as follows:

To prohibit any vehicle from proceeding in the lengths of road set out below at any time, except for loading and unloading by goods vehicles, which will be permitted between 4 p.m. and 11 a.m., and access by emergency vehicles or statutory undertakers, which will be permitted at any time:

Market Place (west side) – from the junction of King Street with Regent Street to the junction of the west side of the Market Place with The Conge.

Market Place (east side) – from the junction with St. Nicholas Road to the junction with Market Gates.

Market Gates – from the junction with the east side of the Market Place, eastwards, for approximately 15 metres.

The Norfolk County Council (King Street and Regent Street, Great Yarmouth) Experimental (Prohibition of Driving) Order, 1988

To prohibit any vehicle from proceeding in the lengths of road set out below at any time, except for loading purposes and except for buses and taxis:

King Street – from the junction with Regent Road to the junction with Regent Street.

Regent Street – from the junction with King Street to the junction with Howard Street South.

The Norfolk County Council (Howard Street South, Great Yarmouth) Experimental (Prohibition of Driving) Order, 1988

To prohibit any vehicle from proceeding in the length of road set out below at any time, except for access purposes, otherwise than in a southerly direction:

Howard Street South – from the service road (to the south of the Central Arcade) to Regent Street.

The Norfolk County Council (Market Place, Great Yarmouth) Experimental (Prohibition of Driving) Order, 1988

To prohibit any vehicle from proceeding in the lengths of road set out below at any time, except for emergency vehicles and statutory undertakers vehicles:

The Norfolk County Council (Various Roads, Great Yarmouth) Experimental (One-Way) Order, 1988

To prohibit any vehicle from proceeding in the lengths of road set out below, otherwise than in the direction specified opposite each length of road:

Regent Street – from the junction with King Street to the junction with Howard Street South in an east to west direction.

St. Nicholas Road – from the junction with Temple Road to the junction with Priory Plain in an east to west direction.

Priory Plain – from the junction with St. Nicholas Road to the junction near No. 23, Priory Plain in a south to north direction.

Howard Street South – from the junction with Regent Street to the north side of the Friends Meeting House in a south to north direction.

Hall Plain and Greyfriars Way – from the junction of Hall Plain with Regent Street to the junction of Greyfriars Way with Howard Street South in a north to south direction.

Howard Street South – from the junction with Stonecutters Way to the junction with St. Francis Way in a south to north direction.

The Norfolk County Council (Regent Road, Great Yarmouth) Experimental (Reserved Bus Lane) Order, 1988

To introduce a reserved bus lane on the south side of the carriageway with buses travelling one way, from east to west, and to restrict other vehicles to the north side of the carriageway where they will be prohibited from proceeding otherwise than in a west to east direction, in the length of road set out below:

Regent Road – from the junction with King Street to the junction with Deenside.

The Norfolk County Council (Howard Street South, Great Yarmouth) Experimental (Prohibition of Waiting and Prohibition of Loading/Unloading) Order, 1988
