UNIVERSITIES OF OXFORD AND CAMBRIDGE ACT 1923

Amendments made by the Governing Body of Brasenose College, in the University of Oxford on 29th June 1988, to College Statutes I-VI and X, XI, XIII, XVII and XVIII have been submitted for the approval of Her Majesty in Council, and this notice is accordingly published under the provisions of the Universities of Oxford and Cambridge Act 1923.

The purposes of the amendments, *inter alia*, are:

- (1) to modify and clarify provisions relating to the tenure of Junior Research fellowships;
- (2) to clarify the powers of the Principal;
- (3) to reduce the normal retiring age of certain Senior research and Supernumerary Fellows;
- (4) to delete the retiring age of College officers;
- (5) to take account of the obsolescence or disappearance of Entrance Awards, Closed Awards, entrance scholarships and exhibitions;
- (6) to allow the Governing Body to delegate authority to affix the Seal, and
- (7) to take account of changes in pension arrangements. (1 SI)

The Stopping-up of Highways (Lane at rear of Brick Row, Maesteg) Order 1988

The Secretary of State for Wales hereby gives notice that he has made the above Order under section 209 of the Town and Country Planning Act 1971 to authorise the stopping-up of the highway described in the Schedule to this notice to enable development to be carried out.

The Order requires the provision of a new highway which shall be a highway maintainable at the public expense, and for which Mid Glamorgan County Council shall be the highway authority.

Copies of the Order may be inspected free of charge at all reasonable hours at the offices of Ogwr Borough Council, Civic Offices, Angel Street, Bridgend.

If any person desires to question the validity of the Order, or of any provision contained therein on the grounds:

- (a) that it is not within the powers of the Town and Country Planning Act 1971; or
- (b) that his interests have been substantially prejudiced by a failure to comply with any of the requirements of that Act,

he may within 6 weeks of 21st July 1988 apply to the High Court for the suspension or quashing of the Order or of any provision contained therein.

SCHEDULE

(all distances are approximate)

The highway to be stopped-up is at Maesteg in the county of Mid Glamorgan and is the lane situated to the rear of the highway known as Brick Row which extends from its eastern terminal point in a general westerly direction for a distance of 26 yards. (4 SI)
