## TOWN AND COUNTRY PLANNING ACT 1971

The Secretary of State for Transport hereby gives notice that he proposes to make an Order under section 209 of the above Act to authorise the stopping up of a length of Alice Street, three lengths of unnamed highway and seven unnumbered footpaths to enable residential development consisting of a refurbishment scheme on the Perkinsville housing estate at Ouston, Chester-le-Street, to be carried out in accordance with planning permission granted to Wimpey Homes Limited by Chester-le-Street District Council under Part III of the said Act.
