#### KENSINGTON AND CHELSEA ROYAL BOROUGH COUNCIL

##### *Revised Layout of On-street Parking Places*

Notice is hereby given that the Council of the Royal Borough of Kensington and Chelsea, on 22nd July 1988, made the Kensington and Chelsea (Parking Places) (No. 6) Order 1988, the Kensington and Chelsea (Free Parking Places) (Disabled Persons) (No. 1) Order 1988 and the Kensington and Chelsea (Free Parking Places) (Diplomatic Missions) (No. 2) Order 1988, under sections 6, 45, 46, 49 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, as amended by the Local Government Act 1985.

The general effect of the Parking Places Orders will be to:

- (a) Revoke certain residents' parking places in Cadogan Gardens, Ennismore Gardens Mews, Fawcett Street, Hans Place and Powis Square.
- (b) Designate residents' parking places in Cadogan Gardens, Ennismore Gardens Mews, Hans Place, Powis Square and Queen's Gate Place Mews. (Season tickets for sols motor cycles costs £3 for 3 months or £10.50 for 12 months and for all other vehicles costs £14 for 3 months, £26 for 6 months, of £45 for 12 months. Saturdays only season tickets cost £20 for 12 months.
- (c) Provide that the hours of operation of the designated parking places referred to above would be between 8.30 a.m. and 6.30 p.m. on Mondays to Fridays inclusive and between 8.30 a.m. and 1.30 p.m. on Saturdays with the exception of those parking places in Cadogan Gardens, Ennismore Gardens Mews and Hans Place which would also operate between 1.30 p.m. and 6.30 p.m. on Saturdays.

The General effect of the Disabled Persons' Parking Places Order will be to:

- (a) Revoke the disabled parking place in Cadogan Gardens.
- (b) Designate disabled parking places in Chepstow Crescent, Kensington Park Road and Powis Square.
- (c) The disabled parking places are provided for the use (between 8.30 a.m. and 6.30 p.m. on Mondays to Saturdays) of those vehicles displaying a valid disabled persons' permit.

The general effect of the Diplomatic Missions Parking Places Order will be to:

- (a) Revoke the diplomatic parking places in Lennox Gardens and Fawcett Street.
- (b) Designate diplomatic parking places in Lennox Gardens and Fawcett Street.

A copy of each of the Orders, which will come into operation for the purposes of placing of traffic signs, etc. on 25th July 1988, and for all other purposes on 1st August 1988, and of all other relevant documents can be inspected during normal office hours on Mondays to Fridays inclusive until the end of 6 weeks from the date on which the Order was made in:

- (a) The Information Office, Chelsea Old Town Hall, King's Road, London S.W.3;

(b) The Parking Control Office, The Town Hall, Hornton Street, London W.8; and

(c) The Parking and Traffic Orders Office, Central Depot, 37 Pembroke Road, London W.8.

Copies of the Orders may be obtained from the Council's Directorate of Engineering and Works Services, Central Depot, 37 Pembroke Road, London W8 6PW.

Any person desiring to question the validity of the Order, or of any provision contained therein on the grounds that it is not within the relevant powers of the Road Traffic Regulation Act 1984, or that any of the relevant requirements thereof or of any relevant regulations made thereunder has not been complied with in relation to the Order may, within 6 weeks of the date on which the Order was made, make application for the purpose to the High Court.

#### KENT COUNTY COUNCIL

*The Kent County Council (Various Roads, Tenterden) (Prohibition of Waiting) Order 1988*

Notice is hereby given that on 21st July 1988 the Kent County Council made an Order under sections 1, 2 and 124 of the Road Traffic Regulation Act 1984, the effect of which will be to extend the existing restrictions on the waiting of vehicles at all times in the following lengths of road at Tenterden:

- (1) *Beacon Oak Road*, south-west side, from its junction with Golden Square for a distance of 55 metres north-westwards to a point in line with the south-eastern boundary of No. 40 Beacon Oak Road; and
- (2) *Golden Square*, north side, from its junction with Beacon Oak Road for a distance of 37 metres westwards to a point in line with the party wall of Nos. 59 and 61 Golden Square.

Exceptions will be provided in the Order to enable a vehicle to wait with police permission or for passengers to board or alight, for the loading or unloading of goods, for enabling works to be carried out in or adjacent to the road, for disabled persons, for taking on oil, petrol, etc., and for emergency service vehicles.

A copy of the Order which comes into operation on 27th July 1988 and a map showing the lengths of road concerned may be inspected during normal office hours at Room 1.31, County Hall, Maidstone.

If you wish to question the validity of the Order, or of any provision contained in it on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1984, or on the grounds that any requirement of that Act or of any Instrument made under it has not been complied with in relation to the Order, you may, within 6 weeks of the date on which the Order was made, apply to the High Court for this purpose.

#### KENT COUNTY COUNCIL

*The Kent County Council (High Street (A262) and North Street (A274) Biddenden) (Prohibition of Waiting) Order 1988*

Notice is hereby given that on 21st July 1988 the Kent County Council made an Order under sections 1, 2 and 124 of the Road Traffic Regulation Act 1984, the effect of which will be to extend the existing waiting restrictions at all times at Biddenden as follows:

- (1) *High Street (A262)*:
  - (a) on the north side from its junction with North Street (A274) for a distance of 27 metres westwards;
  - (b) from its junction with North Street for a distance of 35 metres north-westwards; and
  - (c) from a point approximately 22 metres from the southern boundary wall of No. 4 High Street for a distance of 22 metres in an easterly direction.
- (2) *North Street (A274)*:
  - (a) on the west side from a point 50 metres south of its junction with the Weavers for a distance of 17 metres southwards; and
  - (b) from a point approximately 12 metres from the eastern boundary wall of No. 2 High Street for a distance of 29 metres southwards.
